1. The Environment Agency (including its statutory predecessors) is and has been the owner, within the meaning of the above Section,

1.1. since 14 October 1938 of the land known as Harbour Masters Cottages, Camber

1.2. since 5 January 1972 of the land falling within HM Land Registry Title No SX139809

1.3. since 19 September 1973 of the land falling within HM Land Registry Title No SX157217

all of which said land is together more particularly delineated on the plan accompanying this statement and edged red (excluding that part edged red and coloured dark green).

2. The aforementioned land lies in the Parish of Camber.

3. Save for Public Footpath Camber 5 there are no public rights of way on the land.

4. No other ways over the land have been dedicated as highways.


5. The deposit shall comprise this statement and the accompanying plan.

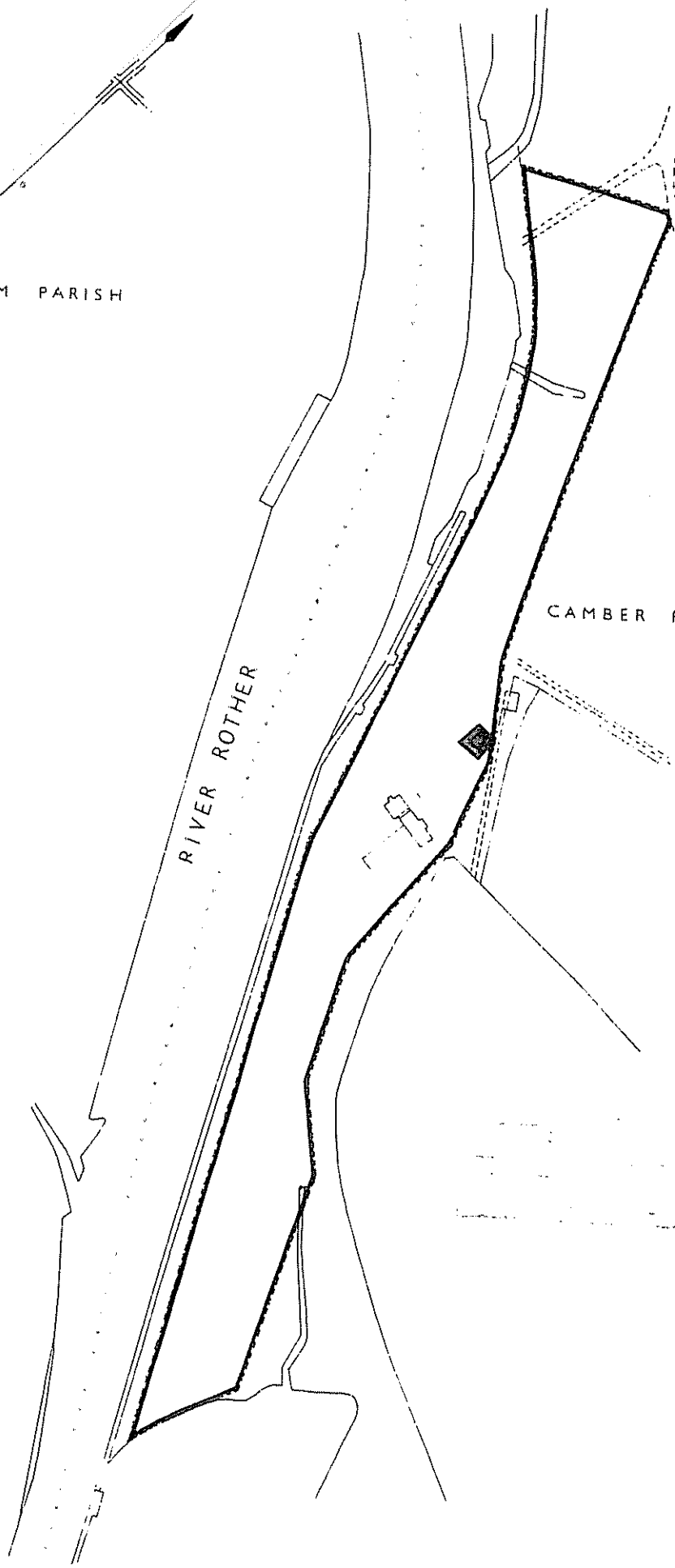
