National Lottery Heritage Fund - The Changing Chalk Partnership Project

A partnership of 10 organisations has received initial National Lottery support for the Changing Chalk project. Made possible by National Lottery players, the partnership will work with local communities and landowners to connect people with nature and address challenges facing the Sussex Downs to protect this fragile chalk grassland landscape for future generations.

Development funding of £138,300 has been awarded by The National Lottery Heritage Fund to help the [Changing Chalk partnership](#) progress their plans to apply for a full National Lottery grant of £2,234,600 in 2021.

Changing Chalk is focused on the chalk grassland landscape of the Sussex Downs and the communities of the coastal urban fringe of Brighton and Hove, Eastbourne and Lewes.

The landscape and communities are facing multiple threats. On the Downs, the internationally significant chalk grassland is facing rapid decline with only 4% of original habitat remaining. At the same time, there is increasing public recognition of the importance of nature and place as a determinant of individuals' health and well-being.

This project will bring together people and nature, over a five-year period, to tackle these threats, grasp the opportunities and celebrate the heritage that the area offers. The vision is to reverse the decline in chalk grassland and establish a long-term collaborative management plan, which is sustainable because of the benefits it will provide for people.

The partnership will use the development funding to apply for a full National Lottery grant in 2021. If successful the project aims to empower communities, share and

celebrate how people over generations have shaped the South Downs and inspire people to get involved and connect with their local landscape.

This would include a Big Dig archaeological project, starting in Eastbourne, which would enable communities to explore and record local history of their Downland settlements.

Sussex Community Foundation - Rampion Fund

The [Rampion Fund](#) recently announced details of latest awards including some in East Sussex. The fund has given out over £200,000 in its latest round of grant-making to 17 local projects that involve renewable energy, energy conservation, energy efficiency and sustainability.

The Rampion Fund is managed by Sussex Community Foundation, and supports the local community, from Littlehampton Harbour in the west, to Beachy Head in the east and up to the A272 near Twineham in the north.

Sussex Police and Crime Commissioner – Safe Space Sussex Funding Network

The Police and Crime Commissioner holds a statutory responsibility to commission local victim and witness support services and receives a grant direct from the Ministry of Justice to do so.

The [Safe Space Sussex Funding Network](#) was designed to ensure the services the Commissioner commissions for victims and witnesses of crime are the best they can be as promised in the Police and Crime Plan. All providers must be approved through a quality assurance process before they are able to receive funding.

Occasionally the Commissioner will release a competitive funding tranche for one off grant funds to increase capacity or allow organisations to start innovative projects. After an assessment procedure took place, the following projects in East Sussex were marked as successful and awarded funding:

Department for Digital, Culture, Media & Sport – Consultation on Dormant Assets

The government has launched a public [consultation](#) that is expected to lead to millions of pounds worth of unclaimed financial assets being used for “good causes”.

The plans will expand the release of unclaimed dormant assets from bank and building society accounts to also cover products related to insurance, investment and wealth management, and securities.

Under the scheme, unclaimed funds are held by Reclaim Fund Ltd, which holds enough money to cover any claims from the public and then distributes the surplus to the National Lottery Community Fund.

So far more than £600m has been redistributed to good causes. Over £400m from the original scheme was used to establish Big Society Capital, the independent financial institution that was launched in 2012 with the aim of growing the social investment market in the UK.

The consultation is open until 23:59 on Thursday 16th April.

National Lottery Heritage Fund - Digital Confidence Fund

The National Lottery Heritage Fund has launched a new initiative to support heritage organisations across the UK to develop their digital skills.

The Fund says that 2,500 people are expected to benefit from the free training to develop their digital skills. It will invest nearly £500,000 in the provision of advice and support on how to integrate digital tools into heritage work more effectively.

What Works Well-Being – Good Childhood Report 2019

There is growing concern about the mental health of children in the UK which has led to efforts to identify groups of children who are at higher risk of mental health problems. The understanding has, however, been hampered by apparent contradictions in recent research. For example, a recent NHS survey reported higher rates of mental disorder in children who lived in low-income households or with a parent receiving income related benefits. In contrast, a 2019 Department for Education report found that teenage girls from more disadvantaged backgrounds reported better psychological health. What is the reason for these disparities in the evidence?

The [Good Childhood Report 2018](#) suggested that these different conclusions are partly related to using different measures of mental health. The sixth sweep of the Millennium Cohort Study, conducted with children aged around 14 years, contains:

- A measure of children's emotional and behavioural difficulties (EBDs), designed to measure emotional symptoms, peer problems, conduct disorders, hyperactivity/inattention, and pro-social behaviour, reported by parents
- A measure of depressive symptoms reported by children, statements about the last two weeks, such as 'I didn't enjoy anything at all'

Analysis in [The Good Childhood Report 2019](#) also highlighted the importance of the poverty measure/s used. Financial strain (reported by the parent) was more strongly related to children's depressive symptoms than household income was. Other evidence, suggests that children's direct experiences of deprivation may affect their wellbeing much more than objective measures of their family economic status.

The analysis also shows the importance of measuring a range of mental health issues. Children's depression at 14 years old is much more strongly connected with self-harming than whether they have emotional and behavioural difficulties.

Department of Health and Social Care (DHS) - The Office for Students (OFS)

The [Office for Students](#) (OfS) is inviting higher education providers to develop and implement projects which provide innovative approaches to improving mental health outcomes for students.

OfS are administering this competition on behalf of the Department of Health and Social Care, which has provided £1 million for this scheme.

OfS are seeking collaborative proposals with a particular focus on intersectional approaches to:

- Preventative strategies for those students who might be considered particularly at risk of developing mental ill health
- Driving improvement in access to support for those who might be likely to experience additional barriers (for example, because of the nature of their course, mode of study, or other factors such as structural, personal or cultural differences or inequalities)

In meeting these priorities, OfS are also particularly interested in projects that explore innovation and the use of technological approaches in line with the new NHS drive for digital transformation and improvement in mental health support.

Bids should deliver activities that address one of the following priorities:

- Particular groups of students with characteristics identified as increasing the risk of poor mental health (e.g. ethnicity, socioeconomic background)
- Groups of students who might experience barriers to accessing support due to their course, mode of study, or other characteristics (e.g. those on placements as part of their course, commuters, mature students, part-time students, postgraduate taught students, international students, first in family, carers, care leavers, LGBT+)

Where appropriate and realistic, proposals can cover more than one priority, but this is not an expectation. OfS encourage bids to be focused in their approach and do not expect them to cover all groups of students within a particular priority area. Rather, OfS want to see evidence-based, innovative bids focused on a particular group of students.

Proposals must be collaborative and underpinned by a strategic approach and firm evidence base, with the aim to develop more effective practice and accelerate the pace of change in supporting the mental health, and preventing mental ill health, of students in higher education.

This funding opportunity is open to higher education providers who are in the 'Approved (fee cap)' category of the OfS Register as at 5th March 2020.

OfS expect all projects to have at least one partner, but this does not have to be another higher education provider. For example, partners could include health agencies and third sector organisations.

A total of £1 million is available for this fund. Individual awards will be made at a minimum of £70,000 and up to a maximum of £200,000.

2020 Postcode Lottery Green Challenge for Entrepreneurs

The [Postcode Lottery Green Challenge](#) is a contest rewarding inventions that successfully combine sustainability, entrepreneurship and creativity. The jury looks for products and services that contribute to an eco-friendly lifestyle, directly reduce greenhouse gas emissions and score highly on convenience, quality and design.

Would-be entrepreneurs aged 18 years or older with a well-thought-out idea are invited to participate in the Challenge, which is open in Great Britain, Germany, Netherlands, Norway and Sweden.

The competition aims to elicit promising, creative ideas that will encourage and aid the invention of new green products and services and combat CO2 emissions, and which can be put on the market quickly.

There is a total of €1 million in combined prize money available for the five best start-ups. The winner will receive €500,000 (£ 426,000) to further develop the product or service, and to bring it to market. The runner-up will receive €200,000 and the three other finalists receive €100,000 each.

The prizes, together with the assistance from leading professionals, will enable the winners to develop their inventions and present them to the world within the next two years.

National Lottery Community Fund/The King's Fund - The Healthy Communities Together programme

The National Lottery Community Fund (TNLCF) and The King's Fund are jointly supporting partnership-working in local areas between the voluntary and community sector, the NHS and local authorities to improve the health and wellbeing of local communities.

The [Healthy Communities Together programme](#) will offer up to £3 million of grant funding and £850,000 of leadership development support to develop effective and sustainable partnerships to improve health and wellbeing, reduce health inequalities and empower communities.

The programme will enable partners to develop their relationships, to identify and agree what they need to work together more effectively to ensure the involvement of organisations working across communities, and to collaboratively create a plan to deliver meaningful change. This may include:

- Developing infrastructure to engage the VCSE and enable effective partnership
- Developing a local approach to measuring impact on health and wellbeing
- Co-producing ways of commissioning and delivering services for particular groups of people, such as groups who are marginalised, have complex needs or live with long-term conditions
- Developing a commissioning framework which supports the diversity of the VCSE sector locally (for example, including very small organisations) or
- Developing community-centred approaches which aim to involve and empower local people in improving health and wellbeing

The programme will fund partnerships that must include:

- A voluntary, community and social enterprise sector organisation
- A local authority, and
- An NHS organisation (including Clinical Commissioning Groups, NHS Trusts and primary care bodies)

Both new partnerships, and one that's already been set up are eligible to apply. Partnerships must cover a defined 'place' in England.

The programme consists of two phases. In phase 1, a maximum of six areas will receive up to £50,000 funding from The National Lottery Community Fund and a package of learning and development support from the King's Fund for up to nine months to develop their partnership and project plans.

At the end of this phase, each site will be invited to apply for phase 2 of the programme for further funding and support.

Successful partnerships will receive up to £450,000, as well as ongoing learning and development support from The King's Fund, over a further three years.

Sport England - Emergency Funding for Storm Damaged Pitches and Facilities

In the wake of Storm Ciara, Sport England has announced that community, voluntary and social enterprises can request up to £5,000 of emergency funding which could be awarded in just a few weeks.

The funding will be awarded through Sport England's [Community Asset Fund](#), which was designed to help communities quickly respond to emergencies or unexpected events that stop people from being active.

The Sport England team aims to provide quick responses to those sports clubs most badly affected by the recent storm. The grants could typically be used to restore grass pitches, to repair and decontaminate flood or wind-damaged clubhouses, replace damaged electrical systems or dredge blocked drains.

Architectural Heritage Fund - Transforming Places through Heritage Grants

The [Architectural Heritage Fund's](#) programme supports projects that will contribute to the transformation of high streets and town centres in England helping them become thriving places, strengthening local communities and encouraging local economies to prosper. It is part of a wider initiative to revive heritage high streets in England, alongside Historic England's High Street Heritage Action Zones.

This programme is for individual heritage buildings in, or transferring to, community ownership. They will support charities and social enterprises to develop projects with the potential to bring new life to high streets by creating alternative uses for redundant or underused historic buildings in town centres.

A range of grants are available:

- Project Viability Grants: up to £15,000, for early viability and feasibility work, open now for applications

Partnership Grants Schemes have now reopened for 2020 and Biffa Award are welcoming online Expressions of Interest for both [themes](#) for between £250,000 and £750,000 for large-scale projects of regional or national significance. In a change from 2019, both themes will be considered by the board in both rounds.

- Built Environment projects should aim to restore, modernise and improve facilities such as cultural, heritage or visitor centres to engage and encourage tourists and/or day visitors. The facility should be inclusive and inspire and promote learning, creativity and participation
- Natural Environment projects should aim to restore or improve the environment and the natural systems or habitats that support it. Projects should be working to Biodiversity 2020, A Strategy for England's Wildlife and Ecosystem Services, its successor, or a Local Biodiversity Action Plan target

BlueSpark Foundation

Schools, colleges and community groups can apply for [grants](#) to Blue Spark Foundation for a wide range of projects. The Foundation value academic, vocational, artistic and sporting endeavour in equal measure but are particularly keen to support projects which will help enhance the self-confidence, team working skills and future employability of children and young people.

Many grants will be under £2,000, most will be under £5,000 and only in a few cases will grants exceed £10,000.

Projects which could be supported include drama, music, sport, art and design, debating, public speaking, academic education, vocational training, community projects, enterprise projects and educational excursions. Bright Ideas Fund

Not-for-profit organisations that have been established for five years or less that want to set up their own community business can apply to [The Bright Ideas Fund](#) for

business support and grants. The community business must be based in England and have a charitable purpose which meets charitable needs in the community.

The Fund has so far provided support to 120 community groups, including the following projects:

- A community energy scheme re-using cooking oil from local residents to generate electricity and power local buses
- A community-led cookery school and catering enterprise in an ethnically diverse neighbourhood to improve social cohesion and skills
- A community transport scheme to link isolated rural villages and give elderly people more independence
- An indoor skatepark for a forgotten coastal community with few activities for young people and poor health
- A community food club tackling food poverty through pop ups
- A community darkroom to give local people a place to be creative and turn a hobby

To be considered for the programme, the community business must be locally rooted, trading for the benefit of the local community, accountable to the local community, and have broad community impact. In addition, it must deliver benefit in the seven core impact areas set out by the programme.

Successful organisations will receive business development support, grant funding of up to £15,000 which can be spent on specific activities to develop their idea, as well as learning and peer networking.

The first step in the application process is to complete the eligibility checker. This must be done by 5pm on Monday 6th April 2020. The deadline to submit an application is midnight on 7th April 2020.

Hospice UK - Widening Access to Dementia Care and Mental Health Support in Hospice Settings 2020

[Hospice UK](#) is making capital grants available for projects that improve the physical environment within which hospices deliver care. The programme aim is to support patients with dementia or a mental health condition and their families.
